This is in response to community feed-back and demand from parents who are in need of a summer camp option and after school programs in their community4c (Code:) (Expenses \$ 26,300. including grants of \$ 26,000.) (Revenue \$)The Steve Johnsen Scholarship program hands out scholarships to youth that have been participants of DICP programs and to former school program students (La Academia). The school shut down in 2018. Through an endowment from the sale of the school building, scholarship recipients receive funds to further their higher education goals. Plans for the program this are to bolster the program to include a fellowship program, internships, and youth employment.
